Checklist for First-Year Students

Immunization and Communicable Disease Form

Due November 15 – First Year Only

- TB Test- A 2-step test is required in the first year
- COVID-19 - Include proof of 2 doses of the vaccination.
- Tetanus must be up to date with booster received every 10 years
- Provide a copy of all childhood to present immunizations
- Include Serology Reports for MMR, Varicella and Hep B

CPR – Level C, HCP, or BLS required

Due Annually

- You can either find an agency that provides this service in your hometown (Level C, HCP, or BLS with an in-person component) or choose to have this done on campus during the Fall sessions.

Criminal Record Check with Vulnerable Sector Screening

Due Annually

- If you are not 18 years old, a signed declaration is required - email: trentclinical@trentu.ca
- If you turn 18 during the academic year you must apply for your CRC with VSS on that date and submit it as soon as you receive it. Please keep a copy of your invoice as it may be requested
- Can take up to 6-8 weeks to have completed by Police Detachment

N95 Mask Fit

Due Bi-Annually

- You can either find an agency that provides this service in your hometown (N95 Respirator) or choose to have this done on campus during the Fall sessions (Only offered on Peterborough Campus).

Influenza Vaccine

Due December 1st Annually

- The influenza vaccine will be available through your MD or at a local pharmacy.

Workplace Health & Safety Modules

Due November 15 – First Year Only
